



NEW PROGRAM INITIATIVES & ENHANCEMENTS

Disaster Relief Assistance Program: Provides support for members of the Knights of Peter Claver and Ladies Auxiliary as well as Churches housing Claver units affected by natural disasters. In 2016, the program assisted approximately 100 Clavers affected by natural disasters.


Increased Educational Giving: Contributed to the inaugural Office of Black Catholics Bishop Carmon Endowed Scholarship Fund, provided 26 scholarships on behalf of the National Scholarship program, and an additional 3 scholarships through the Augustus / Tolton Fund to students at Xavier University of Louisiana, the only historically Black Catholic University in the country.

- Initiated involvement in the annual GiveNOLA Day online community support fundraising drive to solicit contributions and matching funds in support of the Youth Micro-Grants Program.






Youth Micro-Grants GiveNOLA Day Fundraiser




